SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

Inhalation

Get medical attention. Place unconscious person on the side in the recovery position and ensure breathing can take place. Move injured person into fresh air immediately. Call an ambulance. Be aware that symptoms of lung oedema (shortness of breath) may develop up to 24 hours after exposure. Bring these instructions.

Ingestion

Skin contact

Immediately flush with plenty of water for up to 15 minutes. Remove any contact lenses and open eyelids widely. If irritation persists: Continue flushing during transport to hospital. Bring these instructions.

4.2. Most important symptoms and effects, both acute and delayed

Inhalation

Harmful if inhaled Vapours may cause headache, fatigue, dizziness and nausea.

Harmful if swallowed. May cause nausea, stomach pain and vomiting.

SECTION 5: FIREFIGHTING MEASURES

5.1. Extinguishing media

Specific hazards

Vapours are heavier than air and may travel along the floor and in the bottom of containers. Vapours may be ignited by a spark, a hot surface or an ember. Vapours may form explosive air mixtures even at room temperature. If a fire or if heated, a pressure increase will occur and the container may burst with the risk of subsequent explosion.

5.3. Advice for firefighters

Special Fire Fighting Procedures

Keep up-wind to avoid fumes. Use water SPRAY only to cool containers! Do not put water on leaked material. Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire.

Protective equipment for fire-fighters

Self contained breathing apparatus and full protective clothing must be worn in case of fire.

7.1. Precautions for safe handling

Avoid contact with skin and eyes. Eliminate all sources of ignition. Keep away from heat, sparks and open flame. All handling to take place in well-ventilated area. Use non sparking handtools and explosion-proof electric equipment. Static electricity and formation of sparks must be prevented. Take precautionary measures against static discharges when there is a risk of dust explosion. Storage tanks and other containers must be grounded. Persons with a history of skin sensitization problems should not be employed in any process in which this product is used.
